FEES: Event Fee is \$3,250.00 (\$750 deposit). Total cost of lodging varies according to room type.

Tuition Payment Schedule:

- \$1,200 Second deposit paid one month prior to the start of the Pre-Requisite group work (12/4/18)
- \$1,300 Tuition balance due two months prior to event (4/10/19)

Room and Board Payment:

CANCELLATION AND REFUND OF TUITION: The Esoteric School is actually a 5-1/2 month event — 21 weeks of prerequisite, facilitated practices and group work, plus an 11-day residency. Please read the following cancellation policy carefully.

- **No Cancellation Fee:** In the event you cancel your reservation *more than 30 days before the Pre-Requisite group work begins (by 12/6/18)*, all funds on account will be refunded.
- **\$250 Retained Fee:** In the event you cancel your reservation *29 or fewer days before the Pre-Requisite group work begins (12/7/18 – 1/3/19)*, Nine Gates will retain a \$250 administrative fee. Any additional collected funds on account will be refunded.
- **\$750 Retained Fee:** In the event you cancel your reservation *up to 30 days after the start of the Pre-Requisite group work (1/4/19 – 2/2/19)*, Nine Gates will retain a \$750 administrative and prerequisite work fee. Any additional collected funds on account will be refunded.
- **\$1,200 Retained Fee:** In the event you cancel your reservation *from 31 days into the Pre-Requisite work until 45 days before School residency (2/3/19 – 4/26/19)*, Nine Gates will retain \$1,200 administrative and prerequisite work fee. Any additional collected funds on account will be refunded or transferred to the next School.
- For cancellations *after 45 days before the beginning of the School residency (4/27/19 – 6/9/19)* any tuition above the \$1,200 retained fee can be transferred to the next school, but is not refunded unless in the case of emergency.

All cancellations must be made in writing to Nine Gates Programs, Inc. at the address below.

CANCELLATION AND REFUND OF ROOM AND BOARD:

45 day deadline: Cancellations made 45 days prior to event residency allow for a full refund of room & board fees on account. After 45 days prior to event residency, Nine Gates is committed to pay for contracted room and board. Therefore, cancellations made within the 45 days prior to the start date of the residency will result in participants being liable for their entire room & board fees.
